

## Consent form: SMR/Septoplasty and/or Conchotomy/Turbinate Reduction)

SMR/septoplasty/conchotomy/turbinate reduction surgery is carried out in cases where air flow is obstructed to the point of restricting respiration. In some cases, obstruction to air flow is caused by growth and swelling of the nasal conchae on the nasal lateral septums, with or without deviation of the septum. In these cases, one or both lower conchae may have to be removed/decreased/seared.

Surgery is carried out inside the nose, without any external sections. The surgeon will decide whether to leave supports or tampons in the nasal cavity.

Surgery is usually carried out under general or local anesthesia with sedation.

About the need for SMR/septoplasty/conchotomy/turbinate reduction surgery on the \_\_\_\_\_ side due to \_\_\_\_\_ (hereinafter: "the procedure")

I was informed that in some cases, this surgery will not solve the functional problem.

I hereby declare and confirm that I received an explanation about the side effects of the procedure, including pain and discomfort, hemorrhaging, scabs and odor in nose, decrease (usually temporary) in sensitivity of the upper teeth and the frontal part of the palate.

Furthermore, I received an explanation about the possible risks and complications of the procedure, including: sinusitis, perforation of the septum that may cause wheezing, scabs and hemorrhages, adherence of septum to conches, modification to the external form of the nose, impaired sense of smell (rare), dryness of the mouth, significant hemorrhaging requiring repeated surgical intervention, life threatening infection from tampons, abscess in septum requiring surgical drainage.

I hereby give my consent to performance of the procedure.

I hereby declare and confirm that I have received an explanation and am aware of the possibility that in the course of the procedure the need may arise to extend its scope, modify it or use other or additional procedures to save life or prevent physical damage, including additional surgical procedures that cannot be foreseen certainly or fully at this stage, but their significance has been explained to me. I therefore also consent to said extension, modification or other or additional procedures, including surgical actions institution physicians believe to be vital or required during the course of the procedure.

I am also providing my consent to undergoing local anesthetics with or without intravenous injection of sedatives, after having received an explanation about the risks and complications of local anesthetics including various degrees of allergic reactions to sedatives and possible complications due to the use of

sedatives that may, rarely, cause respiratory disorders or cardiac disorders, particularly among cardiac patients or those with respiratory system disorders.

I was informed that should the procedure be performed under general anesthesia, the anesthetist will give me a relevant explanation about it.

I am aware that and consent to the procedure and all other procedures to be carried out by the person to whom it was allocated according to the institution's procedures and instructions, and I have not received any assurance that the procedure or a part thereof will be carried out by a particular person, provided it is carried out within the responsibility accepted by the institution and subject to the law.
